Sub: Declaration of Voting Results of Postal Ballot through remote e-Voting

Dear Sirs/Madams

- (1) I, Sudhansu Sekhar Panigrahi, Practicing Company Secretary (ACS 23187 /CP 19649) was appointed as Scrutinizer by the Company for conducting Postal Ballot and E-Voting process in a fair and transparent manner in terms of resolution of Board of Directors passed on 11th September, 2024.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to E-Voting and Postal Ballot on the resolutions contained in the Notice of Postal ballot and E-Voting dated 11th September, 2024. My responsibility as a scrutinizer for the voting process through electronic means and Postal Ballots is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the report generated from the e-voting system of Central Depository Services (India) Ltd (CDSL) and of voting through Postal Ballots as provided by M/s Maheshwari Datamatics Private Limited, Kolkata the agencies engaged by the Company to provide e-voting and Postal Ballot facilities.
- (3) I submit the report as under:
 - i. The Company has completed the dispatch of Postal Ballot Notice (Containing E-Voting instructions) via electronic mode by 11th September, 2024 to its members whose names appeared on the Register of Members as on 6th September, 2024.
 - ii. Members were provided the opportunity to cast their votes only through electronic voting system in terms of platforms provided by CDSL E-Voting System. (www.evotingindia.com)
 - iii. The e-voting period remained open from 9 a.m. IST on Sunday the 15th day of September, 2024 up to 5 p.m. IST on Monday the 14th day of October, 2024.
 - iv. The share holders holding shares as on the "cut off" date i.e. 6th day of September, 2024 were entitled to vote on the proposed 4 (Four) resolutions as mentioned in the Notice of Postal Ballot dated 11th September, 2024.



v. The result of electronic voting were downloaded on Monday, the 14th October, 2024 around 6.54 pm after the completion of E-Voting in the presence of two witnesses namely Mr Pawan Kumar of 75 Metcalf Street, 2nd Floor, Kolkata – 700 013 and Mr Subir Karmakar of 75 Metcalf Street, 2nd Floor, Kolkata – 700 013 who are not in the employment of the Company.
